HELP US CELEBRATE OUR 150th!

On May 10th and 11th, 2018, the Fourth District Dental Society of New York State will be sponsoring the 23rd annual Saratoga Dental Congress (SDC) and celebrating the society's 150th Anniversary! The meeting will be held at the Saratoga Springs City Center in Saratoga Springs, NY. (A 2018 program is attached). At our 2017 meeting, we had over 550 attendees and more than 40 exhibits.

BOOTH FEES

A fully draped booth with one table and sign bearing your company name is \$650. The fee includes lunch for two exhibitors. For each exhibitor over two, the charge for lunch will be \$30.00 per person, per day. Take advantage of the Early Bird Rate (\$650) by **submitting your registration form and payment by April 27, 2018**. Post-deadline, the fee increases to \$725. The Dental Society reserves the right to refuse registrations when all booths are filled. Payment for booth space must be received by May 4, 2018 or the reservation will be cancelled.

EXHIBITOR KIT & SET-UP

An exhibitor kit will be emailed to each registered exhibitor approximately four weeks before the meeting from the district office. The kit will contain an order form to request furniture and accessories, electric power, special signs, labor and drayage. Payment for these services is to be made to Clifton Park Convention Services (CPCS). Your exhibiting materials will also be shipped to CPCS. The exhibit hall will be available for set-up from 1:00–5:00 pm on Wednesday, May 9th, 2018. You may also set-up Thursday, May 10th at 7:00 am. Exhibits will open Thursday, May 10th and Friday, May 11th at 8:00 am.
