The meeting was attended by over 400 dentists, hygienists and staff, and there were over 45 corporate presenters. NYSDA President-Elect Brendan Dowd greeted the attendees on Thursday and welcomed everyone with his opening remarks. Thursday's program included renown occlusion scholar Dr. Jeffrey Okeson, who challenged us to consider the different possible problems with the TMJ before treating dysfunction. Participants were captivated by Dr. Tieraona Low Dog's presentation on nutrition and natural medicine. Friday's schedule included Dr. Roy Shelburne and Nancy Dewhirst. Dr. Shelburne's eye opening presentations on dental coding and avoiding prison time kept the audience's close attention. Nancy Dewhirst educated us about health risks to dental providers and practical knowledge about ergonomics. ## Fourth District leaders at Washington Leadership Conference

On April 9th and 10th, 2018 the ADA held its largest, and one of the most successful Washington Leadership Conferences and Lobby Day with over 1200 Dentists and Dental Students from all over the country in attendance. The ADA Washington staff, key Congressional leaders, and political pundits spent the first day preparing the group to visit Senators and Congressmen to discuss the opioid crisis, student debt, and other oral health concerns.

Dr. Mike Breault is the ADPAC Action team leader for Congressman Paul Tonko, Dr. Mark Bauman is the leader for Congressman Elise Stefanic, and Dr. Kirk Gleason is the leader for Congressman John Faso. Through the years each have worked with all the local Congressmen and our two US Senators, even as the Congressional Districts have been redrawn and the Congressmen have been replaced. To be more effective they work as a team and have met with each Congressmen, both in Washington and in upstate New York. Thus they personally know these national leaders and are more readily welcomed to their offices.

This year the three dentists had the opportunity to visit all three Congressmen on the same day and spent very productive time with each. They also escorted several dental student representatives to the offices so they could personally discuss the student debt issue, and this was very well received by each of the Congressmen.

Drs. Breault, Bauman, and Gleason are also all on NYSDA's EDPAC Committee and work closely with NY State Assemblymen and Senators on behalf of the Fourth District members. They were also actively involved with NYSDA's State Lobby Day in February along with several other leaders from the District. And of course all members receive a letter from them each year encouraging you to join the Capital Club of EDPAC to further the important political action being done on your behalf to protect your profession and further oral health.



## What is Laverne's Law?

On January 31st, 2018, Governor Cuomo signed Laverne's Law. This law amends the statute of limitations for medical, dental or podiatric malpractice cases involving negligent failure to diagnose cancer or a malignant tumor. Prior to Laverne's Law, a patient had 2 1/2 years from the date of the missed diagnosis to pursue a claim for malpractice. Now, the statute of limitations is 2 1/2 years from the date that the patient discovered or should have discovered the missed diagnosis, up to seven years from the date of the last treatment. It is important to note that Laverne's Law only applies to malpractice cases involving cancer.
