# Letter from the President



**Greetings from the Fourth** District. I would like to extend a special thanks to Dr. Laura Johnstone, our outgoing president, for her service to the district over the last two years. It's been an interesting couple of years to say the least. Our members have persevered through one of the most uncertain and anxious periods in the history of organized dentistry. Thankfully, our profession has seen a surge in demand in the second half of 2021 and in the first quarter of 2022 as our patients continue to emerge from the global pandemic. Nearly three months of mandated shutdown followed

by months of uncertainty and fluctuating rates of Covid-19 infection in the community led to a significant decline in the dental health of many of our patients. Almost two years later, it appears that the worst is behind us, but a lot of work is still needed as we play "catch up." I'm confident that we are up to the task. I've been humbled and frankly surprised at the attitude and gratitude expressed by my patients during this time. Rarely did I encounter a patient concerned about their well-being in the office, even during the height of the pandemic. I was reminded of the level of trust and confidence that our patients have in our judgement and expertise not simply as dental professionals, but as health care professionals.

There was time in the thick of this however when patient interactions were limited or all together absent. Many of us, myself included, took the opportunity to catch up on CE. Quite appropriately, for a couple of years now, our governing bodies have relaxed the in-person

#### **Opinion: Access to Care for the Intellectual and Developmentally Disabled** Dr. Laura Johnstone

If a government program exists but no one can access it, does it really serve a purpose? Special needs New Yorkers, their families, and their caregivers are waiting in pain. Individuals with profound intellectual and developmental disabilities (IDD) in New York State often require access to hospital operating rooms in order to have appropriate dental care under the safety of general anesthesia. Most are on Medicaid. In 2008, the NYS Dept of Health changed from reimbursement of providers based on the cost of the use of the facility to reimbursement based on the amount of procedures completed and the perceived complexity or intensity of the procedures. Without adequate financial support, the network of dental OR programs began to crumble. The result is a dismaying access to care issue that continues to plague the hospital-based dentistry system.

Our previous Governor and his Medicaid Redesign Team refused any increases in Medicaid expenditures with no exceptions for the IDD population despite provisions in the Affordable Care Act that allow for increases in reimbursement for this treatment. (This same state government denied IDD group residences qualified for PPE disbursement during the pandemic, reversing course only when the NYCLU and NY Disability Rights groups filed complaints citing the Americans with Disabilities Act.) OR work of anesthesiologists and dentists is not valued under Medicaid as much as other treatment. Hospitals aim for \$6000-7000 per hour for OR use; dental treatment for IDD patients often only brings in \$500-1500 for a 2-3 hour procedure. Anesthesiology will receive anywhere from \$120-155 for this case. As for the dentist? Standard Medicaid dental rates apply.

In spite of the significant clinical challenges of treating this vulnerable segment of society, providers are not only disincentivized by current reimbursement levels, rather they are financially penalized. If no providers agree to treat them, how can they cost the state any money? When attempting to understand someone's motivation it is often instructive to surmise it from the outcome. The current system of reimbursement is not designed to motivate provider participation.

Making matters worse there is typically a 2-year waiting period for dental treatment in this population. NYS has 214 hospitals – only 30 currently provide OR treatment for IDD individuals. Our area has witnessed the loss of IDD/OR dental programs at Ellis and St. Peter's Hospitals, as well as the closure of the Helen Hayes Hospital OR in Hudson Valley. COVID restrictions have exacerbated the issue. There is also a shortage of dentists who feel comfortable treating patients that have adverse/combative behaviors or who feel that they have sufficient training with this population. This problem is projected to get worse as more New Yorkers develop Alzheimer's Disease. There are currently 410,000 patients with Alzheimer's Disease in NY State, with 70% of the 80,000-100,000 of moderate cases likely to need general anesthesia for dental care, conservatively.

As individuals and as a society, we are judged not by how we treat the most glamorous and privileged amongst us. Rather it is how we prioritize the most vulnerable – those that cannot advocate for themselves – that holds a true mirror to who we are as a profession. Right now, someone has a family member that cannot get potentially life-saving treatment because we have not summoned the collective will to demand better, to demand what many of them cannot demand for themselves. Let us not wait until someone dies of an abscess to call awareness to this problem.

To combat these shortfalls and correct the cruelty that prolonging dental care can inflict, the NY Taskforce for Special Dentistry is asking the NYS government to fund a Fellowship for Special Needs Dentistry at 6 academic and 6 hospital locations and train more dentists to do work at this scope. If you feel so moved by the plight of these families, please contact Lisa Hicks at the Fourth District to receive a template that can be forwarded to your local representative and voice your concerns regarding the treatment of the most vulnerable segment of our population.

#### The Politics of Dentistry

On the evening of April 19th, 2022 NYSDA hosted a webinar entitled "The Politics of Dentistry: A View From Washington" which included viewpoints from NY Congressman Andrew Garbarino, NYSDA Lobbyist Roy Lasky and ADA Senior VP and Washington Lobbyist Michael Graham, as well as other state and local members involved in the political efforts of the ADA and dental political action campaigns. They discussed the lobbying efforts that are made at a national level, including those made during the pandemic to ensure that dental offices were included in the PPP, EIDL, HHS and other programs. The ADA is one of the few organizations which has a physical presence in Washington D.C. on both the House and Senate sides of town, in order to be as connected to lawmakers as possible. It is these relationships with both Republicans and Democrats which allow the ADA to be heard and effect the legislative process to the benefit of the dental profession. Congressman Garbarino spoke to the power of hearing from dentists and dental students about their personal experiences. There was discussion of the efforts to nationalize the licensure process for dentists, as this is a common concern for newer dentists who are more likely to move to another state over the course of their career. It is contributions to the political action campaigns such as ADPAC and EDPAC that ensure dentists have a voice in future legislation.
