Monkeypox Resources for Healthcare Providers (NYSDA July 22, 2022)

The CDC is requesting that healthcare providers be alert for patients who may have signs of monkeypox, including oral lesions, regardless of gender or sexual orientation, recent travel, or have specific risk factors. Healthcare providers should look for signs and/or symptoms during patient exams, continue to use appropriate PPE, and thoroughly clean all surface areas.

The NYS Department of Health hosted a webinar for healthcare providers in order to provide a situational update on the evolving monkeypox outbreak in New York City and New York State. The webinar discussed how to identify symptoms, testing, infection control protocol and more. Information can be found on the NYSDA website.

New State Law for Opioid Prescription

Effective June 27, 2022, under certain circumstances, doctors in outpatient settings prescribing an opioid for pain management may also be required to simultaneously prescribe an opioid antagonist (such as Narcan/Naloxone) to the patient.

This new <u>LAW</u> applies to the first opioid prescription to a patient each year when any one of the following conditions are known to exist:

(a) a history of substance use disorder; or

(b) high dose or cumulative prescriptions that result in ninety morphine milligram equivalents or higher per day; or

(c) concurrent use of opioids and benzodiazepine or nonbenzodiazepine sedative hypnotics hypnotics (including but not limited to diazepam/Valium, Lorazepam/Ativan, Clonazepam/Klonopin, Xanax, Ambien, Sonata, and Lunesta).

Note that the law is interpreted such that each provider's first opioid prescription of the year to a patient is subject to this law. It does not matter if the patient already had received another opioid prescription from a different provider earlier in the year. If it is your first opioid prescription to the patient that year <u>and</u> one of the noted conditions exist, <u>you must also prescribe</u> <u>an opioid antagonist</u>.

NYS CE Requirements for Dentists

NYS Department of Education has extended the deadline for self-study continuing education for dentists. Until January 1, 2023, all continuing education requirements can be completed as self-study. After the deadline, 42 out of the 60 required credits will need to be live courses. Below are the current continuing education requirements:

- 60 continuing education credits every 3 year registration period; 18 of the 60 credits can be home study
- NYS Mandated Ethics and Jurisprudence course (once in your lifetime)
- NYS Mandated Tobacco Cessation/Oral Cancer course (once in your lifetime)
- NYS Mandated Child Abuse course (once in your lifetime)
- Active certification in cardiopulmonary resuscitation (CPR); certification varies 1-3 years; CPR must be taken in person
- NYS Mandated Infection Control course, once every 4 years

Alternatively the phone number is 1-800-206-8125. Providers and patients can use this information for billing concerns, access to care issues, etc.

Small Business Tax Credit

Governor Kathy Hochul announced the opening of the initial intake tool to help small businesses, with 100 or fewer employees, determine their eligibility for the COVID-19 Capital Costs Tax Credit Program. The \$250 million COVID-19 Capital Costs Tax Credit Program will support small businesses that made investments to comply with emergency orders and regulations or to increase public safety in response to COVID-19. If deemed eligible by the screening tool, a link to the application will be provided when the program application opens. "The pandemic has hit New York's small businesses especially hard, forcing many to close and others to incur significant financial burdens to protect their employees and customers from COVID-19," Governor Hochul said. Small businesses were hit particularly hard by the pandemic downturn. This new refundable tax relief program targets COVID-19-related expenses. Eligible COVID-19-related costs include, but are not limited to:

- Supplies to disinfect or protect against COVID-19 transmission
- Costs associated with expanding, or defining space to accommodate social distancing
- HVAC equipment
- Expenses related to increased outdoor activity and outdoor space expansions
- Machinery and equipment to facilitate contactless sales

Tax credits will cover 50 percent of eligible costs, up to \$50,000, for a maximum tax credit award of \$25,000, and credits will be awarded on a first come first serve basis until program funds are depleted. Eligible businesses must operate a location in New York State, have 100 or fewer employees, \$2.5 million or less of gross receipts in the 2021 tax year, and at least \$2,000 in eligible costs between January 1, 2021 and December 31, 2022.

Businesses are still encouraged to apply for the New York State COVID-19 Pandemic Small Business Recovery Grant Program which provides flexible grants of \$5,000 to \$50,000 for small businesses for COVID-19 expenses. However costs incurred between January 1, 2021 and April 1, 2021 that were paid for with proceeds from this grant program are not eligible for a tax credit under the COVID-19 Capital Costs Tax Credit Program.

To receive a tax credit for their 2022 tax return, businesses must receive a tax credit certificate from ESD on or before December 31, 2022. Potential applicants are urged to complete the screening tool and apply as soon as the program is launched, as any tax credits issued on or after January 1, 2023 cannot be claimed until a business's 2023 tax return. Governor Hochul Signs NYSDA Dental Assisting Bill Into Law (NYSDA August 19, 2022)

A bill to allow registered dental assitants to place and remove temporary restorations was signed into law by Gov. Hochul on August 17, 2022. The law takes effect immediately. In 2007, the NYS Education Department mandated that registered dental assisting programs teach and train registered dental assistants to place and remove temporary restorations, thus declaring in its official directive from then Deputy Commissioner for the Professions Frank Munoz to such academic programs that these procedures were within the scope of practice of RDA and assistants needed to be educated and trained to perform them. However, the RDS scope-of-practice law was never updated to match that directive, which has been carried out ever since 2007. The bill fixes that technical glitch to match the existing education standards and training of RDA to their scope-ofpractice law.




2022 Award Recipient Ms. Ashley Warner
